## Proposed RA/RCC Indoor Recreation Facility

The Reston Association and Reston Community Center Boards, through a Joint Task Force, have been working together since early last fall on exploring the potential for a joint indoor recreation facility that would include indoor aquatics, tennis, gymnasia, program and community space parking. and the required **Both** organizations have identified needs for additional indoor recreation space, as well as community use space. We are early in The firm Brailsford & process. Dunlavey (B&D) was hired to conduct a market and feasibility study to determine the community needs, and to gauge whether Reston could support additional indoor recreation space.

The B&D final report was due on June 1, 2009, and should be posted on the RA website soon thereafter. The Joint Task Force commenced the community engagement portion of the process on May 18 and the Lake Anne / Tall Oaks District meeting is on July  $9^{\rm th}$ .

#### **Neighborhood Pool**

Our neighborhood pool, Tall Oaks, recently began its "Season 3" schedule, which runs from June 19 to August 16:

Weekdays Noon – 8 PM Weekends 11 AM – 7 PM Closed on Tuesdays

"Season 4" commences August 17 to September 7 and reduces opening times to only Weekends 11 AM – 7 PM.

Reston Association Pool and Tennis Passes are necessary to gain admission to the pool. Passes are available now at the RA Member Services Desk, 1930 Isaac Newton Square (M-F 8:30-5:30), or online at www.reston.org.



Membership cards are \$15 for adults 18 years or older and \$10 for children. Family Pass Packages are offered for \$60 (2 adults and 3 children). Season Guest Passes are \$25 and are good for one guest per visit, while One-Day Guest Passes are \$5 each (available in packs of five) at the pool or RA main office, valid only for the day purchased.

RA Members 18 years and older must have a current photo ID and proof of owning or occupying a residence (upon which the RA assessment is current) in order to purchase passes for themselves and immediate family members.

Free sunscreen is available at any RA pool – just in case you forgot yours.

#### **Mosquito Season**

We are soon approaching the height of the mosquito season. It seems appropriate to look at how we can cut down on the number of mosquitoes breeding in our back yards and at the same time reduce the thread of West Nile Virus.

According to a brochure put out by the Fairfax County Health Department, mosquitoes are poor fliers, so if they are a problem where you live, they most likely were bred in a still water source on or around your property. They are often called "back yard breeders" – they breed and feed in our back yards. So it is worth taking the time to make your yard mosquito free.

#### **Eliminate Standing Water**

The most effective way to control mosquitoes is to eliminate or treat the standing water where the larvae live. Once the adult mosquitoes have emerged, chemical controls give only temporary relief.

- Roof Gutters Clean out leaves and debris frequently. Flush out to ensure that new rain water drains properly.
- Outside Containers Turn them upside down or sideways so they don't collect more water. A mosquito breeding pond can be quite small.
- **Bird Baths** Clean and change the water every few days.
- Wading/Kiddie Pools Change the water at least every few days and turn it upside down when it is not in use.
- Puddles and Wet Soggy Areas –
   Drain the water off or fill with dirt or other material.
- Ornamental Ponds Stock with small fish or add a recirculating pump.

#### **Townhouse Communities**

In a townhouse community, it is particularly important that we monitor standing water. One water filled container could provide a breeding ground for mosquitoes that would later infest many of our neighbors' yards and gardens. •

#### The Emerald Ash Borer



You may have noticed what appear to be strange purple triangular box kites hanging from or secured to trees in the area. They are being utilized in a multinational effort to detect, monitor and research the emerald ash borer population and contain their infestations.



An exotic, shiny, metallic green beetle about half an inch in length and native to Asia, the borer is a highly destructive and invasive species, especially in its immature larval stage. It has been responsible for killing tens of millions of ash trees since its detection in the US in 2002 and threatens to kill most of the ash trees throughout North America, costing tens of millions of dollars to affected municipalities, property owners, nurseries and the forest product industry.
