Tried And True Recipes

No-Bake Chocolate Peanut Butter Bars



- 1 cup of butter, melted
- · 2 cups of graham cracker crumbs
- 2 cups of powdered sugar
- 1 cup of peanut butter
- 1-1/2 cups of semisweet chocolate chips
- 4 tablespoons of peanut butter

In a medium-sized mixing bowl, stir together butter, graham cracker crumbs, powdered sugar and peanut butter until well blended. Press into the bottom of an ungreased 9 x 13" baking pan.

Using a double boiler over hot (not boiling) water, melt the chocolate chips with the 4 tablespoons peanut butter, stirring occasionally until smooth. Spread on top of the mixture in the baking pan.

Refrigerate an hour before cutting into bars.

Makes about 24, depending on how you portion the bars. •
