## Cluster Board Meeting 7-16-2019

- Call meeting to order at 7:35PM
- Present at the meeting Eileen DuBose, Keith London, Martin Dapot, Bill Wagner, Jon Rojas, Jane LeGros, Jason Askew, and Shelly Hallonquist.
- Membership forum:
  - o 1518 Park Glen frustrated about limbs from large maple tree falling on parked cars.
    - Neighbors will switch spots if they want
- June meeting minutes approved with changes at 7:51 PM
- Budget and finance:
  - Cluster investments will mature in October 2019. Cluster will reinvest this money.
    Cluster will also invest a portion of the cluster reserves.
  - During next board meeting we will discuss 1508 Scandia Circle paying cluster dues from settlement sheet.
  - Budget and Finance report approved at 8:12 PM
- Landscaping committee:
  - o The Chestnut Oak beside 1519 Park Glen received a second Chestnut Borer treatment
  - Around the two areas of the tot lot the landscape committee requested \$680 to clean up weeds and other undesirable plant material.
    - Motion approved at 8:18pm. Jason Norris JLN landscaping will complete the work.
  - Dead bushes above retaining wall, located on Park Glen Court, will be discussed by the Landscape committee during the August meeting.
  - o French drain projects located on Farsta have been completed.
  - 1500 Park Glen Court, Cardinal Landscaping not mulching or mowing cluster property adjacent to homeowner. Will remind cardinal to take over this portion.
  - Landscaping report approved at 8:31 PM
- Cluster projects:

  - o Reston Association DRB paperwork for cluster signs was completed and sent.
