- Membership Forum:

 - \$2,544 over budget for general maintenance. 8% over budget. We can deviate up to 10% if we have a budget problem on a specific budget line item. If we take more from a particular budget, we must take from another. If we need to spend more money, we can take it out of other budget areas, but requires 2/3 directors vote.
 - Trash removal has gone up by \$250 a month. Probably due to tonnage increase.
 - Contributions to reserves proposing asphalt/street/parking reserves monthly contributions to be dropped so we can use for other projects.
 - o Transfer retained earnings to reserves at the end of the year.
 - Approved budget and finance report at 8:28 PM.
